Ballots will arrive by mail for June 24 Primary Election

Visit www.arapahoevotes.com to register to vote or affiliate with a political party

Littleton, CO – Active registered voters in Arapahoe County who are affiliated with the Democratic, Republican or American Constitution Party will receive a mail ballot for the June 24 Primary Election. Voters may return their ballot with 70 cents postage, or deliver it to one of 20 drop-off locations around the county by 7 p.m. on Election Day. Six drop-off boxes will be open around the clock for added convenience.

“Ballots will be mailed beginning June 2 to active voters who are affiliated with a major political party,” said Clerk and Recorder Matt Crane. “We encourage our citizens to vote and return their ballot before Election Day in order to avoid potential lines at Voter Service and Polling Centers or ballot drop-off boxes.”

The Primary Election will determine which candidates will appear on the Nov. 4 General Election ballot and vie for local, state and congressional seats.

Currently, 113,367 registered voters in Arapahoe County may not vote in the Primary Election unless they affiliate with a major political party. This includes unaffiliated voters, and those registered with the Green or Libertarian parties. Unaffiliated voters who wish to affiliate may do so up to and including Election Day. Affiliated voters who wish to change their affiliation must do so by May 23 in order to vote in the Primary.

Inactive voters will not automatically receive a mail ballot. In order to reactivate a voter registration record and receive a mail ballot, please call the Elections Division at 303-795-4511.

Four Voter Service and Polling Centers will open June 2 to citizens who wish to register to vote in-person, affiliate with a party, update a voter record, or replace or request a ballot. These are located inside Arapahoe County’s Motor Vehicle branch offices in Aurora, Byers, Centennial and Littleton.

Voters can find locations and hours for ballot drop-off boxes and Voter Service and Polling Centers at www.arapahoevotes.com. This website also offers links to register to vote, update a mailing address, choose a political affiliation, view a sample ballot and track their mail ballot through the Postal Service.

Ballots will not be mailed after June 17. Voters must go in-person to a Voter Service and Polling Center after this date to register to vote in-person and request a ballot.
