Primary Election ballots should now be delivered in-person to ballot boxes *Timeframe has passed to return ballots by mail*

LITTLETON, CO – Voters in Arapahoe County who have not mailed their Primary Election ballot should now deliver it in-person to one of 20 ballot boxes around the county. Delivering your ballot in-person will ensure it is received on time. Ballots must be received by Arapahoe County (not postmarked) by 7 p.m., Tuesday, June 24 in order to be counted.

“We’re suggesting that voters return their ballot in-person at this point, instead of by mail, to ensure it is received in time and their voice is heard in this election,” said Clerk and Recorder Matt Crane. “We’ve only received approximately half of the anticipated ballots, so we’re strongly encouraging voters to drop-off their ballots this weekend, in order to avoid potential lines and wait times on Election Day.”

The following ballot drop-off locations are open during business normal hours Friday and Monday, as well as offer extended hours from 9 a.m. – 1 p.m., Saturday and 7 a.m. – 7 p.m., Tuesday. Six ballot boxes are available around the clock.
