## Clerk and Recorder Matt Crane to serve as President of Colorado County Clerks Association in 2016

**LITTLETON, CO** – Arapahoe County Clerk and Recorder Matt Crane will represent the interests of all Colorado counties as President of the [Colorado County Clerks Association](#) in 2016. He was sworn in Jan. 19 alongside the Executive Board at the Association's Winter Conference at the Hilton Fort Collins.

CCCA is a non-profit association comprised of Colorado's 64 county clerk and recorders, who are responsible for issuing marriage and civil union licenses, recording real estate transactions, registering voters, conducting elections, and titling and registering vehicles on behalf of the State.

Crane was elected by his peers and previously served as Vice President in 2014 and President-elect in 2015. As CCCA President, Crane will represent counties on legislative issues, promote communication with the Secretary of State's Office and the Colorado Department of Revenue, and foster best practices in advance of the Primary and Presidential Elections. Crane also will host the CCCA Summer Conference in Arapahoe County in August and will serve as co-chair of the CCCA Legislative Committee.

"I'm truly honored to lead our professional association and serve my peers in 2016," said Crane. "This is an incredibly exciting year as county clerks prepare for a new motor vehicle title and registration computer system; seek funding mechanisms to upgrade our electronic document recording systems; and begin transitioning to the State's new uniform voting system for elections. Our work this year will really lay the groundwork for counties for the next decade."

Crane also serves as Colorado State Delegation Director to the International Association of Clerks, Recorders, Election Officials and Treasurers. He is one of seven county representatives on the Colorado State Titling and Registration System Advisory Committee. He also holds professional memberships in the Colorado Municipal Clerk's Association, the National Association of County Recorders, Election Officials and Clerks; and Election Center (National Association of Election Officials.) He is a Certified Election Administrator through Election Center and the Colorado Department of State.

Crane was elected Arapahoe County Clerk and Recorder in November 2014, after serving in the role since March 2013, when he was appointed to fill a vacant seat. He previously worked as Arapahoe County's Deputy of Elections and Elections Operations/Special Projects Manager, as well as in elections administration for Denver County, Wyant Data Systems and the Colorado Department of State.
